The Pleasant Valley Joint Fire District is soliciting bids for vendor(s) to design and build a metal pole barn at 650 W. Main Street, Plain City, Ohio 43064. Sealed bids for each project shall be hand delivered to the Pleasant Valley Joint Fire District, at 650 W. Main Street, Plain City, Ohio 43064, until **3:30 PM. Friday, July 12, 2019**, to provide labor and materials for **“A METAL POLE BARN FOR THE PLEASANT VALLEY JOINT FIRE DISTRICT, UNION COUNTY, OHIO”**.

Bids will be publicly opened and read aloud by the Pleasant Valley Joint Fire District, Union County, Ohio at 650 W. Main Street, Plain City, Ohio 43064 on **Monday, July 15, 2019 at 1:00 PM** LOCAL TIME.

A **Mandatory Pre-Bid Conference** for all interested contractors will be held at the offices of the Pleasant Valley Joint Fire District, Union County, Ohio at 650 W. Main Street, Plain City, Ohio 43064 on **Friday, June 28, 2019 at 10:00 AM** LOCAL TIME. **Any and all Contractors intending to bid this project must attend this Pre-Bid Conference in order for their bids to be considered by the Owner.** Contractors should notify Bryan Adams via email at badams@pleasantvalleyfire.com that they will be attending the Pre Bid meeting.

Each bid shall contain the full name of each person and company interested therein and shall be accompanied by 1) a bid guaranty and contract bond in the full amount of the bid tendered or 2) a certified check, or cashier's check in an amount equal to ten percent (10%) of the bid tendered. Either of these shall serve as a guarantee that, if the award is made to the bidder, he will enter into a proper contract. The successful bidder will be required to furnish a satisfactory performance bond for one hundred percent (100%) of the contract price upon execution of the contract. All such bonds, certified checks and cashier's checks shall be made payable to the **Owner, PLEASANT VALLEY JOINT FIRE DISTRICT, UNION COUNTY, OHIO.**

No bid shall be considered unless made on the forms available at the office of the Pleasant Valley Joint Fire District and in accordance with the Contract Documents which consist of all advertisements, instructions to bidders, specifications and drawings, bid form of contract agreement, bid and performance bond, and all addenda thereto, all of which are available upon request.

Should any bid be rejected, the Bid Bond will be returned forthwith to the bidder, and, should any bid be accepted, the Bid Bond will be returned upon proper execution of a contract agreement.

No bid may be withdrawn for a period of sixty (60) days minimum after the scheduled closing time for the receipt of the bids.

ADVERTISEMENT

The attention of bidders is called to statutory requirements of the State of Ohio relating to the licensing of corporations organized under the laws of any other state; signing of a Non-Collusion Affidavit and Personal Property Statement and their return with the bid. Bids are to be clearly marked on the outside of the envelope in the lower left hand corner as follows: **“A METAL POLE BARN FOR THE PLEASANT VALLEY JOINT FIRE DISTRICT, UNION COUNTY, OHIO”**.

The **OWNER** intends to accept the lowest and most responsible bids (bidders) for the project, and reserves the right to reject any and all or parts of any and all bids and to waive informalities or irregularities that do not affect the substance of the specifications. The Owner will consider combination bids as part of determining the lowest most responsible bids.

Contract Documents will be available at the **Mandatory Pre Bid Conference**. Each contractor must request from the Pleasant Valley Joint Fire District a set of contract documents desired to obtain prior to attending the Pre-Bid.
